

Awareness Initiatives of Ant-Ragging Committee on Policies with Zero tolerance

- Anti-Ragging posters issued by UGC to create awareness among students about ill effects of ragging was displayed at various locations in the campus such as academic building, students notice board, college canteen, college hostel and main gate of the college.
- The poster contained the details of the committee members along with their contact numbers and the 24X7 helpline number of the UGC anti-ragging cell.
- Students were made to submit the copy of the anti-ragging affidavit forms (personal and guardian's copy) to the college.
- The college filled up the anti-ragging compliance form for institutions.
- The anti-ragging committee visited the Girls' hostel and interacted with the students and informed them about the ill effects of ragging and the possible consequences of indulging in such activities.
- Students were made aware of the ill effects of ragging and how to lodge a complaint through an orientation programme on anti-ragging.
